

The adoption of the Recovery and Resilience Plans - official documents



This document provides summarised and tabular information on publicly available official documents relating to the Recovery and Resilience Plans. It will be regularly updated.

Scope of the paper

This paper presents, in a number of annexes, relevant information regarding the adoption of the Recovery and Resilience Plans (RRPs). [Annex 1](#) compiles a set of links pointing to official documents relating to RRPs, together with links to the 2019, 2020 and 2022 Council Country Specific Recommendations (CSRs) addressed to the Member States. It further includes a table summarising the total amounts requested and available per Member State ([annex 2](#)) and the Commission's overall assessments of the national RRPs ([annex 3](#)) and [annex 4](#) provides data on pre-financing disbursements.

Parliament's activities regarding the RRF are displayed on a specific website (see [here](#)). The Parliament's website contains information on events taking place in Parliament and links to available information, among others.

The Commission is also making available compiled information through a dedicated webpage ([here](#)). In its dedicated webpage, the Commission provides, notably, the Staff Working Documents assessing national plans (SWD, available [here](#), together with other relevant documents, notably Commission country-specific summaries), and summarised horizontal information on submitted plans (available [here](#), [here](#) and [here](#)). Additional information on implementation of the RRF can be found in the Commission [RRF Scoreboard](#), launched on 15 December 2021. The Scoreboard displays, notably, a downloadable list of all milestones and targets met by the Member States. The Scoreboard is yet to include information on [common indicators](#).

The Recovery and Resilience Facility in a snap-shot

The Recovery and Resilience Facility, as set up by [Regulation 2021/241](#), of 12 February 2021, aims at providing financing to Member States, through grants and loans, to finance reforms and investments put forward in Recovery and Resilience Plans (RRPs). Member States are required to present a coherent set of reforms and investments in order to receive financing from the RRF. The Commission assesses the plans and proposes their adoption to Council through Council implementing decisions. Such decisions set milestones and targets that Member States will implement to access financing. Once milestones and targets are reached, Member States may require payments from the RRF. These requests are assessed by the

Commission and the Economic and Financial Committee is asked to give an opinion on the Commission positive assessment. The Commission then authorises payments through an implementing decision after asking for the opinion of a comitology committee set up of representatives of the Member States ([RRF Committee](#)).

Under the RRF Regulation, disbursements to Member States can either be:

- (a) pre-financing or
- (b) "regular" disbursements.

Pre-financing is only possible if the relevant Council implementing decision is adopted by 31 December 2021. Pre-financing can be granted at the request of a Member State and once the Council approves the Commission assessment of the RRP (article 13 of the [RRF Regulation](#)). Amounts disbursed as pre-financing can be adjusted following adjustment to the Member States maximum financial allocation¹ and will be discounted from further disbursements to the Member States² under the Facility. Pre-financing is, thus, an anticipation of disbursements; it will need to be fully recovered if a Member State fails to make tangible progress on milestones and targets within 18 months of the date of the adoption of the Council Implementing Decision. [Annex 6](#) lists the pre-financing disbursements made by the Commission (around EUR 56,5 billion). No further disbursements of pre-financing are envisaged, considering the requirements of the RRF Regulation.

On [18 May](#), the Commission published a [Communication](#) setting out its plan to reduce dependence on Russian fossil fuels and foster the green transition, accompanied with a [proposal](#) to amend the RRF Regulation. The amending act foresees, in particular, that Member States will be providing new chapters to their RRPs covering additional investments and reforms aiming at reinforcing EU energy autonomy. The package comprised additional documents, namely [guidance](#) to Member States on the new RePowerEU chapters and [proposals to finance](#) the additional spending under RePowerEU. EP adopted its negotiation position on the Commission proposal in November 2022.

The Regulation foresees that 30% of the maximum financial allocation to member States will be adjusted on the basis of actual outturns in relation to the change in real GDP 2020 and the aggregated change in real GDP for the period 2020-2021 (see article 11(2) of the RRF Regulation). The Commission will publish the updated amounts by the end of June 2022.
